### 1.0 Terms of Service

- 1.1 Rate A applies to Monday to Friday from 08.30hrs until 16.30 hrs. Travel charges would be limited to 8 hrs per day.
- 1.2 Rate B applies to other times excluding U.K. public and bank holidays. Travel charges would be limited to 8 hrs per day.
- A minimum 4-hour charge will apply to all visits at the prevailing chargeable rate plus all other applicable charges.
  Travel charged at the appropriate Engineering rate will apply to travel time to and from the engineer's location to the customer's premises.
  - This location address may be his Company, home, hotel or other Company premises.
- 1.5 A call out charge will apply for any unscheduled engineering needed within 24 hrs or if the engineers return time is after 18:00 hrs
- 1.6 Payment terms are **30 days** from Invoice date unless otherwise specified in writing.
- 1.7 Charge rates will still apply when service work access is temporarily or otherwise denied.
- 1.8 Xmas and New year holiday rates variable and subject to contract.
- 3.0 Expenses Excluding V.A.T.
- 3.1 Hotel and travel expenses incurred after a completed site visit may be charged to comply with applicable legislation or to reduce travel times.

- 4.2 Charge rates & expenses will be applied to any site visit not attributable to a warranty failure.
- 4.3 Charge rates & expenses will be applied to any site visit to modify designs previously approved by the customer.

## 5.0 Engineering Reports

- 5.1 The engineer will submit an engineering report for the work carried out. This report will contain all relevant contract details; an invoice total and breakdown of travel time, work time, and expenses together with a summary of the work completed at the time of submitting.
- 5.2 To comply with the Contract and or applicable legislation, Oracle Drives & Automation Limited, may withdraw or substitute engineers from site or sub-contract engineering services.

#### 6.0 Exclusions

- 6.1 Engineering services not detailed in the Contract or not detailed in these standard terms & conditions.6.2 Risk assessment is not included in these standard terms & conditions.
- EN60204 Part 1 requires customers to comply with the risk assessment needs as set out in the EN Standard.
